Dear Wrestling Official:

The IKWF welcomes you to the 38<sup>th</sup> IKWF Kids wrestling season. It is time to renew your USWOA membership. Every official working an IKWF wrestling match must be USWOA registered. It is your advantage to register early in order for your information to appear on the IKWF website. The official is required to present his registration card to the head official and/or the tournament manager before they can officiate. If you are not registered the day of the tournament the host team may register you at the site of the tournament. Penalties are in place for a host team that does not register any official that does not present a valid USWOA card. Checks for registration must be made out to **USWOA**.

Orders of business:

- 1) Ejection of a coach/wrestler must be reported to the tournament manager.
  - a. A short report of the incident. Name, team, and tournament where incident happened. (Ten day suspension for coach/wrestler).
  - b. E-mailed or mailed to official's chairman immediately.
- 2) If you have already registered:
  - a. Fill out availability form and mail it to official's chairman.
  - b. Fill out application and note that you have already registered. (If you sent your registration to me then you may skip this part-Fargo or online registrations).
